Liability Waiver / Hold Harmless Agreement

The undersigned, as a guest, hereby assumes all risks incident to equine related activities on the property of Broxton Bridge Plantation and, in consideration of the premises, hereby waives any and all claims which he might hereinafter have against Broxton Bridge Plantation or any of its owners, officers, directors or agents, by reason of any injury sustained by him/her while participating in equine related activities or otherwise using said property. Further, the undersigned, in consideration of his invitation to participate in equine related activities on said property, hereby covenants and agrees to indemnify Broxton Bridge Plantation and its owners, officers, directors or agents, jointly and severally, from and against any and all liability, damage or expense incurred on account of any injury inflicted or caused by the undersigned upon Broxton Bridge Plantation property or its other guests or their property while participating in equine related activities on said property. By signing below, the undersigned acknowledges that he has read the "Rules" of Broxton Bridge Plantation and this waiver and understands its terms and that by accepting the invitation to be on the property of Broxton Bridge Plantation agrees to follow any and all rules promulgated by the owners, officers, directors or agents of Broxton Bridge Plantation as suggested.

Broxton Bridge Plantation Trails Rules

1. As required by South Carolina law, all horses and mules must have proof of current, 12 month Negative Coggins test before unloading. All horses will be checked for proper match at the check-in station. **NO EXCEPTIONS!**
2. While Broxton Bridge Plantation makes every effort to insure that the trails and facilities are safe, **we assume no risk nor liability for injuries resulting from the inherent risks of equine activities, “pursuant to Article 7, Chapter 9 or Title 47, Code of Laws of South Carolina, 1976.”**
3. **All visitors must sign a waiver of liability before participating in any activities on Broxton Bridge Plantation. Minors also need the signature of their parent or guardian and should bring a signed release with them, if their parent or guardian will not be in attendance.**
4. The trees, shrubbery, food plots and lawn on Broxton Bridge Plantation are valuable, esthetically pleasing resources. Consequently, horses or mules should not be tied, ridden, exercised or lunged where trees, shrubbery, food plots or lawn would be damaged. Please do not tie to trailers in the camping area other than for tacking up. **Fires are permitted only in designated areas. Please do not attempt to burn trash in fire pits.**
5. Please, **“Don’t be a Litterbug.”** Return all litter to the proper receptacles **including cigarette butts.** Follow a **“pack it in, pack it out”** policy. Do not discard cans, paper or cigarette butts on the trails or in camping area.
6. Guests are responsible for the removal of all waste created by the animals and uneaten hay to the compost pile or to the appropriate receptacle (much bucket) provided by Broxton Bridge Plantation on a daily basis. This includes, but is not limited to that deposited in stalls, along picket lines, and in camping areas. Please clean up thoroughly before departure.
7. Pets must be caged, kenneled or leashed at all times. **No pets are allowed on trails, in recreation hall or in main lodges.**
8. **The recreation hall is closed to guests from camping area and main lodges after 11:00 p.m. in order to allow those staying in adjacent rooms to rest.**
9. **The recreation hall is off limits to minors, unless under the direct supervision of their parent or guardian.**
10. Please observe all posted signs. Do not trespass on adjacent posted land.
11. **Possession/use of illegal drugs is expressly prohibited and will result in arrest and prosecution.**
12. **Public intoxication, vulgar language and/or lewd behavior are not appropriate behavior at Broxton Bridge Plantation and will not be tolerated. No alcoholic beverages allowed except at your campsite. Please help us to maintain a wholesome family atmosphere.**
13. **Only those 18 years old or older or those with a valid driver’s license are allowed to drive the golf carts.**
