

AGREEMENT FOR RELEASE AND WAIVER OF LIABILITY - ADULT

I fully understand that cross-country horseback riding and foxhunting (which includes riding over fences, riding over other obstacles, and riding in and through steep, wet, and rough terrain) are very dangerous activities. Knowing they are dangerous, I wish to participate in these activities. I accept and assume all the risks of injury (including death) to me and/or my property.

In exchange for being permitted to participate in these activities, for myself, my heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against The Lowcountry Hunt, its masters, staff, officers, volunteers, employees, committee members, Hunt members, guests or any landowners, landholders, or other persons making property available, for any injury (including death), to me or any damage to my horse or to my other property whether from anyone's negligence or not, or any other cause, arising out of my participation in these dangerous equine activities – including foxhunting and other related activities – and I also agree that if anyone makes any claims because of any injury to me (including death), or for any damage to my horse or other property, I will keep all those released by this agreement free of any damages or costs because of those claims. By signing this waiver, I also agree to wear an ASTM-approved helmet when participating in equestrian activities with Lowcountry Hunt.
